ORDER:

In the Government Order 1st read above, among other things, orders have been issued to appoint 56 Assistant Surgeon (Dental) (General) selected by the Medical Services Recruitment Board including one candidate who is covered under Registration issue in the sanctioned posts of existing vacancies in the Directorate of Medical and Rural Health Services and the Directorate of Medical Education temporarily.

2. In his letter 2nd read above, the Director of Medical and Rural Health Services has stated that the following two candidates who were provisionally selected by the Medical Services Recruitment Board for appointment as Assistant Surgeon (Dental) in the Tamil Nadu Medical Service were appointed temporarily as Assistant Surgeon (Dental), as per the orders issued in the Government Order 1st read above:-

Dr.P.Urmila was posted at Government Hospital, Radhapuram, Thirunelveli District as per her option exercised during the counseling held on 17.9.2013 with instructions to

join duty within 30 days from the date of receipt of posting order, failing which her name will be recommended to the Government for removal from the approved list and then no extension of joining time will be granted. Dr.V.Gayathri did not attend the counseling and therefore, compulsory posting was given at Government Hospital, Kadaladi, Ramanathapuram District. But, she has acknowledged the receipt of their office posting order dated:17/09/2013. The Joint Director of Health Services, Tirunelveli and Ramnad has reported that Dr. V. Gayathri and Dr.P.Urmila who have not joined duty to till date. Due to non joining of the above two candidates to the posted place, the posts are kept vacant which has resulted in much difficulties in the smooth functioning of the Government Hospitals in providing uninterrupted heath care to the poor public. He has, therefore, requested necessary orders removing the names of Dr. P. Urmila and Dr.V.Gayathri from the approved list based on which candidates may be called for from the Medical Services Recruitment Board, Chennai to fill up the arising vacancy.

3. The Chairman, Medical Services Recruitment Board in his letter 3rd read above, has stated that the following candidates are available in the MBC & DC category:-

Out of the above three candidates, Dr.Vidhya was absent for Certificate Verification and the next candidate Dr.Suganya has not registered her name with Tamil Nadu Dental Council and hence she could not be considered for selection. As such, the third candidate Dr.Brighton is eligible for provisional selection. In the ST Communal category the next candidate is Dr.Manjunath Mandhira Doss (Rank 248). He has, therefore requested to replace the candidates available in the Reserve List as per the communal rotation in the place of non-joining two candidates as detailed below:-
