ORDER:

In the Government Order first read above, the Government have amended the Special Rules for Tamil Nadu Medical Service by giving 5% reservation to those who were deputed for military duty and non-service candidates who have rendered military service in connection with the Short Service Commission or Regular Service Commission in the recruitment to the post of Assistant Surgeon.

- 2. In the Government Order second read above, the Government have directed the Medical Services Recruitment Board to follow the turn and rotation for Ex-Servicemen specified in the Schedule VII to the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 (Tamil Nadu Act 14 of 2016) (applicable to the posts coming under Group C Post) in selection to the post of Assistant Surgeon (Group B Post) who have been deputed for military duty and non-service candidates who have rendered military service in connection with the Short Service Commission or Regular Service Commission.
- 3. In the letter fourth read above, the Director of Medical and Rural Health Services has sent proposal to the Government to amend rule 18 of the Special Rules for the Tamil Nadu Medical Service (Section 21 in Volume II of the Tamil Nadu Services Manual, 1969) in respect of the post of Assistant Dental Surgeon.

- 4. The Government have examined the proposal of the Director of Medical and Rural Health Services to the effect that the post of Assistant Surgeon in the General Line / Assistant Dental Surgeon is recruited by Medical Services Recruitment Board instead of Tamil Nadu Public Service Commission and decided to amend the Special Rules for Tamil Nadu Medical Service for reservation of Ex-servicemen vacancies in the post of Assistant Surgeon in the General Line / Assistant Dental Surgeon and also to brought the said post under the purview of Medical Services Recruitment Board and issue amendments accordingly.
- 5. The appended notification will be published in the Tamil Nadu Government Gazette, Extraordinary dated the 15th July, 2025.

- (2) in clause (b), for the expression "category 2", the expression "Category 2 of Class I and Category 4 of Class IX" shall be substituted;
 - (3) in clause (c), -
 - (a) for the expression "Assistant Surgeons", the expression "Assistant Surgeon in General line and Assistant Dental Surgeon" shall be substituted:
 - (b) for the expression "Tamil Nadu Public Service Commission", the expression "Medical Services Recruitment Board' shall be substituted;
 - (c) for the expression "category 2 of class I", the expression "Category 2 of Class I and Category 4 of Class IX" shall be substituted;

(4) in clause (d), -

- (a) in sub-clause (1), for the expression "Assistant Surgeons", the expression "Assistant Surgeon in General line and Assistant Dental Surgeon" shall be substituted;
- (b) in sub-clause (iii), for the expression "Assistant Surgeon", the expression "Assistant Surgeon in General line and Assistant Dental Surgeon" shall be substituted; and

(5) after clause (d), the following clause shall be added, namely:-

"(e) The turn and the order of rotation for Ex-Servicemen as specified in Schedule-VII to the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 (Tamil Nadu Act 14 of 2016) (applicable to Group-C posts) shall be followed for selection for appointment to the posts of Assistant Surgeon in the General line and Assistant Dental Surgeon (Group-B posts) made by direct recruitment, who have been deputed for military duty and for non-service candidates who rendered military service in connection with Short Service Commission or Regular Service Commission".
