ORDER:-

In the Government Order first read above, orders have been issued for the constitution of Medical Services Recruitment Board exclusively for Health and Family Welfare Department so as to centralize the mode of direct recruitment to all categories existing in Health and Family Welfare Department, except those that are coming under the purview of Tamil Nadu Public Services Commission. In the Government order second read above, Rules of Procedure of Medical Services Recruitment Board for recruitment to various categories have been issued.

2. Subsequently in the Government order third read above amendment to the method of recruitment in respect of Assistant Surgeon (General / Dental / Speciality) and Nurses to the above Rules of Procedure have been issued. In the Government order fourth and fifth read above, amendment have been issued in the method of recruitment to the posts of Physiotherapist Grade-II and Pharmacist respectively.

3. The Director of Public Health and Preventive Medicine in his letter sixth read above has requested to issue necessary amendment to the Rules of Procedures of Medical Services Recruitment Board for adopting written examination for recruitment to the post of Health Inspector Grade-II, based on the observation of the Hon'ble Madurai Bench of Madras High Court in its common order, dated 11.09.2024 in W.P.(MD).Nos.18405, 26269, 18375, 18407, 18411, 18494, 18551, 18595, 18598, 18630, 18716, 18858, 18882, 19976, 19998, 25121 of 2023 and 5272 of 2024.

4. In the letter seventh read above, the Chairman, Medical Services Recruitment Board has requested the Government, to issue necessary instructions / orders regarding mode of selection to be followed for recruitment to the post of Assistant Surgeon (Speciality).

5. The Government have examined in detail the proposal of the Director of Public Health and Preventive Medicine and the Chairman, Medical Services Recruitment Board and decided to accept it. Accordingly the following amendments are issued to the Rules of Procedures of the Medical Services Recruitment Board regarding the method of recruitment to the post of Health Inspector Grade -II and Assistant Surgeon (Speciality).

AMENDMENTS.

In the said Rules, for the existing entries in rule 3(A)(i), the following entries shall be substituted, namely:-

"All Direct recruitment posts in Assistant Surgeon (General / Speciality), Assistant Surgeon (Dental - General / Speciality), Nurses, Physiotherapist Grade-II, Pharmacist and Health Inspector Grade -II shall be made through open advertisement (in atleast two newspapers and one of which must be in vernacular language), by conducting written examination (through physical or electronic mode) duly following the procedures prescribed."

Rule 3(A)(ii) shall be deleted.
