 - b) Any claims preferred by the candidates should reach within 10 days from the date of issue of related provisional selection notification, appeals received after 10 days will not been entertained.
 - c) The Differently Abled candidates shall fulfill the norms as per G.O.(Ms).No.03, Health and Family Welfare (C2) Department dated 06.01.2016.
 - d) The reservation to the posts have been made as per section 27 of Tamil Nadu Government Servants (Conditions of service) Act, 2016.
 - e) The selection is purely provisional.
