The provisional selection and consequent appointment to be made are subject to the outcome of the Writ Petitions viz., W.P.(MD) Nos. 18481 to 18483 of 2017 and WMP(MD)Nos. 14917, 14919 and 14921 of 2017 pending on the files of Madurai Bench of Madras High Court relating to this recruitment and any other cases pending on the files of the Hon'ble High Court, Madras / Madurai Bench of the Madras High Court.
