NOTE:

- a) The candidates have been provisionally selected on the marks scored by them in the objective type examination held on 12.10.2014, verification of the mandated documents, and communal rotation etc. are per the existing orders of the Government of Tamil Nadu. In case where the marks obtained by two or more candidates are equal, the rank among them is decided based on the date of birth.
- b) The result of the candidates whose names are marked with (*) is purely provisional, pending production, verification and acceptance of certain mandated documents called for from them as per the notification (or) verification of certain details in their application. In case of candidates whose selection is withheld for want of documents, the candidate shall produce the same within 30 days from the date of publication of this notification, at the MRB (during the working hours, on any working day). If the candidate fails to produce necessary documents within the stipulated time, it will be presumed that he/she is not able to produce the required documents and his/her provisional selection will be cancelled, without any further notice.
- c) Any claims preferred by the candidates should reach within 10 days from the date of issue of this notification, appeals received after 10 days will not be entertained.
- d) The Differently Abled candidates shall fulfill the norms as per G.O.(Ms).No.25, Welfare of Differently abled Persons (DAP2-1) Department dated 14.3.2013 and G.O.(Ms).No.26, Welfare of Differently Abled Persons Department, dated 27.5.2014.
- e) The Reservation to the posts have been done as per the 200 point roster issued in G.O.Ms.No.65 P&AR Dept. Dated 27.05.2009 and duly taking into consideration of all subsequent instructions of the Government in this regard.
- f) The appointment and posting orders will be issued separately by the Appointing Authority (Director of Public Health and Preventive Medicine)
