f. Certificate of character and conduct issued by the Head of the Institution in which he / she last studied.
g. No Objection Certificate from the Appointing Authority concerned (if applicable) as in Annexure 5 of the Notification.
h. An undertaking and Declaration to be submitted as in para 12A and 12B of notification. (will be provided to the candidate at the venue)
