3. Evidence of Tamil qualification (<i>viz.</i> , SSLC / HSC / Certificate for having passed the second class Language Test (Full Test) in Tamil conducted by the Tamil Nadu Public Service Commission).
4. Community certificate from the competent authority (Permanent Community Certificate)
5. Certificate of character and conduct issued by Group A or Group B Officer on or after 23.02.2024 . (Specimen copy enclosed)
6. Certificate of character and conduct issued by the Head of the Institution in which he / she last studied.
7. Disability certificate issued by the competent authority (if applicable) as in Annexure 7A & 7B of the Notification.
