Notification No.10/MRB/2023 CORRIGENDUM -II

In partial modification of the detailed Notification No.10/MRB/2023 dated:11.10.2023, the following instructions are issued:

As per the instructions in the Government orders, G.O.(D).No:1260, Health and Family Welfare (L1) Department, Dated:31.10.2025, additional online applications on the revised estimate of 2147 vacancies (tentatively) to the post of Auxiliary Nurse Midwife / Village Health Nurse are invited only from women candidates through online mode only from 24.11.2025 and the last date for online application Registration and online payment will be 14.12.2025. It is also informed that the candidates who have already applied to the post of Auxiliary Nurse Midwife / Village Health Nurse need not apply again and the candidates who have paid the fee need not pay the fees once again, they can edit the already submitted application for the Notification No.10/MRB/2023 dated:11.10.2023 to the post of Auxiliary Nurse Midwife / Village Health Nurse.

Explanation:

- * "No Maximum age limit" shall mean that the applicants should not have completed 60 years of age on the date of Notification (or) at the time of selection / appointment to the post.
- ** As per the Government orders, G.O.(D).No:1260, Health and Family Welfare (L1) Department, Dated:31.10.2025, in respect of all applied eligible OC candidates as a one time measure & as a special case (without any maximum age limit), be relaxed in exercise of powers conferred under section 58 of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016.

7. PROCEDURE OF SELECTION:

7a. Selection will be made based on the marks scored by the candidates in their academic and technical qualification(s) for the post of Auxiliary Nurse Midwife / Village Health Nurse duly following the rules of reservation and communal rotation issued by the Government of Tamil Nadu and in satisfaction of the qualification and other conditions stipulated in this Notification. There will be no oral test (Interview) for the post.

Note:

- i. ** Wherever the basic essential qualification for a technical post is a Certificate / Diploma, has been changed from SSLC to HSC, in all such cases the weightage may be restricted to marks obtained in SSLC and the technical certificate/diploma (instead of HSC and the technical certificate/diploma) only.
- ii. In case marks are not awarded for any batch of the Degree / Diploma / certificate course, but only a Certificate or Diploma

or Degree is issued for having passed the examination then selection will be made as per the G.O.(Ms.)No.331 Health and Family Welfare (C2)Department, Dated 05.11.2015 stated that "wherever marks are not awarded to the Technical Qualification but only a certificate or Diploma is issued for having passed the examination, the percentage of marks obtained in SSLC or HSC alone as the case may be taken into account for calculating the weightage of marks".

iii. As per G.O.(Rt).No.1234, Health and Family Welfare (L1) Department , Dated: 04.10.2023, the incentive marks will be taken in to account for those who have worked in the Government Medical Institutions during the COVID – 19 (in the prescribed format as in the Annexure) pandemic for arriving merit list.

7b.The selection will be made for the Auxiliary Nurse Midwife / Village Health Nurse post, duly following the relevant rules of reservation and communal rotation of Government of Tamil Nadu and other conditions stipulated in this Notification.
